### **APPROVAL OF MINUTES**

Motion to approve the minutes by Rep. Bergquist and seconded by Erik Wisner. Unanimously approved as written. No amendments.

### ADVISORY BOARD UPDATES/EDUCATION SEGMENT:

Information Technology Advisory Board (ITAB) Update

CITO Burns-Wallace gave an update from the last ITAB meeting:

- Jeff Maxon, CISO, discussed the Kansas Cybersecurity Act.
- The board also discussed some of the ITEC policies that need to be updated as well as Risk Management Framework.
- There was a general conversation about individuals to share some best practices and challenges around retention and recruitment of IT personnel.

### ACTION ITEM REVIEW

The first action item was reconstituting the IT Security Council. CISO Jeff Maxon will be presenting the draft of IT Security Council Charter at today's meeting.

The second action item was to review the security audit criteria from Legislative Post Audit (LPA) and propose an easy-to-understand metric. Jeff Maxon is working with the LPA to collect information for discussion at the next ITEC meeting.

### **Cybersecurity Governance Update**

CISO Maxon reported on the draft proposal for the Information Technology Policy 7300 draft charter. It was proposed at the last ITEC meeting of reconstituting the IT security council and rebranding the council. This proposal was pushed out to members before the meeting for feedback. CITO Burns-Wallace entertained a motion to adopt ITEC Policy 7300 – Information Security Council Charter as drafted by CITO Weis and seconded by Greg Gann. Motion passed.

### **ITEC Policy Updates**

There are two working groups formed for policies 1100, 1500, and 9500. There is a wide range of state agencies represented. Anyone interested in volunteering are welcome to contact Alex. The groups are meeting weekly, and we plan to provide updates at the next ITAB and ITEC meetings.

### **Introduction of IT Business Risk Assessment**

CITA Wong presented the final draft of the Kansas IT Business Risk Assessment. The assessment has been tested by several agencies with positive feedback. It will be made available for all agencies to use as a planning tool for IT projects.

### Judicial Branch

CITO O'Brien reported that centralized case management system (eCourt) will be going live on track five on July 11<sup>th</sup> which covers forty counties. Once track five is complete in mid-September, we will do track six. The end of October, we will go live in Sedgwick County. The first quarter of next year, we will be deciding if we will do the Appellate court first or Shawnee or Douglas counties. The goal is to complete sometime next year.

### **Executive Branch**

CITO Burns-Wallace reported that we have experienced some staffing issues over the last few months with losing staff in various ways, and challenges in recruiting. We have received strong candidates and filling some vacancies. CITO Burns-Wallace announced that now is the time for rate setting for the agencies. OITS rates have been turned in and overall, have remained flat as we have promised.

### **Legislative Branch**

CITO Weis reported that the veto session was conducted April 25<sup>th</sup> though April 28<sup>th</sup>. The legislative session was completed, and adjourned Sine Die on May 23<sup>rd</sup>. During the legislative session, the IT systems worked fairly well. The legislative staff computer refresh should be completed in the next few weeks. The legislative system modernization project is underway. This project will update the systems for processing the legislative data.

### **CISO Update**

CISO Jeff Maxon reported the current global environment is still elevated. We are encouraging organizations to keep a heightened awareness. We have seen small cities that have experienced difficulties with maintaining a cybersecurity posture. KISO provides a lot of resources free of charge to state and local government entities. If you see anything suspicious, please report to KISO office.

### COMMENTS FROM BOARD MEMBERS

Rep. Curtis mentioned that agencies leadership are taking cybersecurity more seriously. There is work to be done, and making sure local government is stepping up and working with the State together. CITO Burns-Wallace agreed and stated that there were a whole set of recommendations out of the Cybersecurity Taskforce focused at assisting the local level which included coordination and collaboration, but also included certain sets of resources for local units of government that do not have the resources on their own.
